As per the representation of DISCOMs, Consumers and Agencies, it is required to make provision to cancel/modify the Application and to give time limit extension for payment of quotation on SURYA Gujarat portal as well as e-urja system. The matter was put up before the Competent Authority. The following modalities to cancel/modification and to give time limit extension of quotation payment has been approved.

1	Page no. 1 & 2 of application form is filled-up on portal but Page -3 of verification of CAPTCHA is not done and application is not submitted by Agency.	Auto Cancel on 3rd Day i.e. 72 hours from date of filled up to page-2
2	OTP generated but Not verified by Agency within 30 minutes. So agency required to re-generate OTP within 3 days.	Auto cancel if OTP is not entered and submitted within 3 days i.e 72 hours from the time of generation of first OTP.
3	OTP Verified but Documents not Uploaded	Auto Cancel on 10 th Day i.e. 240 hours from the time of OTP verified
4	Document Uploaded but found query and comment raised by DISCOM and it is not complied by Agency	Auto Cancel on 15th Day from the date of query raised by DISCOM . This cancellation shall be soft cancellation and DisCom can re-open the application for another 15 days. But after completion of 15 days, the application shall be cancelled permanently.
5	Documents verified but SR is not generated And request of cancellation of application in written is received jointly signed by Agency and Consumer in hardcopy at Subdivision.	DE of Subdivision will Cancel on e-Urja CRM and portal. (it is desire the application shall be cancel within three days after receipt of consent)

6	Documents verified and SR is generated but deposit not paid And request of cancellation of application in written is received jointly signed by Agency and Consumer in hardcopy at Subdivision.	DE of Subdivision will Cancel on e-Urja CRM and portal after 30 days from date of deposit estimate issued.
7	Documents verified and SR is generated but deposit not paid within 30 days from the date of issue of estimate and no request for TLE is received.	Estimate can be paid within 30 days from date of issued then after Auto Cancel on 37th day of generation of estimate.
8	Documents verified and SR is generated but deposit not paid within 30 days And request of Time limit extension in written is received jointly signed by Agency and Consumer in hardcopy at Subdivision.	If application is received within 30 days from date of FQ issued. TLE for 30 days will be allowed.
9	Request for Change of Inverter Phase :- incase of document verified but SR generation is not done	Phase can be changed on portal by DE after verifying Connection phase and requirement of phase mentioned in EOI specification.
10	Request for Change of Inverter Phase :- Incase of document verified, SR is generated but Deposit is not Paid	Phase can be changed on portal by DE after verifying Connection phase and requirement of phase mentioned in EOI specification.
11	If Deposit for registration is Paid but TFR- and its final estimate including Network augmentation charges is pending to be issued. And request of change of capacity/ change of phase/ cancellation is received	It will not be Entertained for change of capacity. Phase can be changed on portal by DE after verifying Connection phase and requirement of phase mentioned in EOI specification. Application can be cancelled subject to forfeit the paid deposit by Sub division.
12	If Deposit for registration is Paid And TFR- and its final estimates including Network augmentation charges is issued. And request of change of capacity/ change of phase/ cancellation is received	It will not be Entertained for change of capacity. Phase can be changed on portal by DE after verifying Connection phase and requirement of phase mentioned in EOI specification.

13	If Deposit for registration is Paid And TFR- and its final estimates is issued but Final estimate including Network augmentation charges is NOT PAID within 30 Days 1.Timelimit is demanded 2. Time limit is not demanded	If application for TLE is received within 30 days from date of FQ issued. TLE for 30 days will be allowed. Otherwise Auto Cancel on 37th day of generation of FQ.
14	If Deposit for registration is Paid and Final estimate including Network augmentation charges is also paid. And applicant wants to cancel their application	After getting written application duly signed by Agency and consumer, it can be cancelled subject to forfeit the paid deposit and estimate by subdivision.

It is kindly requested to give necessary instructions to concerned officers for implementing the step-5 ,6,13 & 14 of above procedure in field offices with immediate effect. While procedure of Auto cancel will be intimated separately by this office after modification in software by IT Deptt.GUVNL and M/s.Aha solar Pvt Ltd jointly.
