**Sub: Review of quota allocation to Empanelled Agencies of Category B under SURYA-Gujarat Scheme and modality to enhance the quota**

Respected Madam,

As per the provisions of the EOI for Design, Supply, Installation, testing & Commissioning of Grid connected Rooftop Solar Photovoltaic Systems in Residential premises under the SURYA-Gujarat Scheme, 150 MW aggregate SPV Capacity has been allocated to category- B and out of that equal capacity i.e.575.96 KW have been allocated among the 260 no. of Category-B bidders. Looking to the present status of application submitted by Category-B bidders it is observed that some of the Agencies are not participating actively in the implementation of the Scheme and submitted less no. of applications. While some of the category-B Agencies have reached near to their limit of quota 575.96 KW and requested for enhancing their quota to submit more applications.

To achieve the target and looking to the cut off date of 28.02.20 for receiving applications, Competent Authority has approved following modality to enhance the quota of Category-B Agencies:

1. Quota of 100 KW will be added to those Agencies who have submitted application minimum 570 KW and installed SPV systems of minimum 100 KW.
2. Subsequently, additional quota of 100 KW will be allocated after completion of installation of every 100 KW SPV System added time to time subject to installation of SPV Systems maximum up to 7.5 MW per Agency and total quota of Category- B bidders shall not increase beyond 150 MW.
3. The shortfall of SD as PG is required to be paid by the Agency as per the condition of EOI.

Concerned Officer may please be instructed to issue a letter to all the Agencies Empanelled under the category-B to inform them regarding above modality.
